This form is used by holders of emission reduction credit certificates to update contact information for one or more ERC certificates. If the contact information for more than three certificates is being updated, please attach additional pages containing the information requested in Section III. This form cannot be used to transfer emission reduction credits from one holder to another; if credits are being transferred, please use form ERC-4.

**I. Owner's Identifying Information**

This section provides updated information on the holding company's name and/or mailing address. Please complete this section for all notification forms and use the check boxes at the top of this section to indicate if the company name and/or official mailing address have changed.

- A. Current /Former Company Name: Provide the name of the company holding the ERC certificate. In the event that the company name is changing, please provide the current or former company name in this field and provide the new company name in Item B.
- B. New Company Name: If the name of the company holding the emission reduction certificate has changed, please check the appropriate box at the top of this section and provide the new company name in this field.
- C. Mailing Address: Please provide the official mailing address of the company holding the ERC certificate. If this is a new corporate address, please check the "New Address" box at the top of this section.
- D. City: The city corresponding to the official corporate mailing address.
- E. State: The state corresponding to the official corporate mailing address.

**II. Owner's Contact for Sale of Certificate**
